#### First up

1. These terms and the Schedule form the Conditions of Entry for this Promotion and set out all of the information you need to know regarding this Promotion. Capitalised terms have the meaning given in the Schedule, unless otherwise stated. If there's any inconsistency between these terms and the Schedule, then what's in the Schedule is correct. By submitting your entry, you agree that these Conditions of Entry apply to your entry.
2. The promoter is Netball Australia (ABN 66 003 142 818) of 191 Johnston Street, Fitzroy, VIC 3065 (**'Promoter', 'we', 'us'**).
3. Any updates to these Conditions of Entry will be subject to regulatory approval, and will be published on our website <https://netball.com.au/promotions>, so it's important to check these Conditions of Entry regularly.

#### Who can enter ... and who can't

4. The eligibility requirements for this Promotion are set out in the Entry Restrictions. #### How to enter
