

#### **NETBALL AUSTRALIA ATHLETE SELECTION POLICY**

## A. Purpose

The purpose of the Netball Australia (NA) Athlete Selection Policy (Policy) is for NA to select and manage the national squads and teams to represent Australia in international netball matches and World Netball (WN, formerly International Netball Federation) sanctioned events.

## B. Scope and Exclusions

This Policy applies to the NA National Program selected to participate in World Netball Championships, World Netball Series and World Youth Netball Championships and other events and matches as determined by NA from time to time.

The NA National Program comprises of:

- a) Australian Netball Diamonds and squad;
- b) Australia Development/Australia A team and squad;
- c) Fast 5 team and squad;
- d) Australia 21 and Under team and squad;
- e) Australian Black Swans; and
- f) Pathways (including 19/U squad, 17/U squad, and other programs or squads as determined by Netball Australia).

The National Program objectives are to select national squads and teams as determined by NA in preparation for competition in line with the High-Performance Pathway, and to provide the best opportunity for national team success in international competition.

For the avoidance of doubt, this Policy does not apply with respect to participation in the Commonwealth Games.

#### C. Definitions

In this Policy, the following definitions apply:

**Appellant** A person who has commenced a Selection Appeal.

**Appointments Panel** The approved group of persons by the NA Chief Executive Officer who

have the responsibility for the selection of National Selectors under this

Policy.

**Athletes** A registered athlete member of NA and a Member Organisation.

**Business Day** Means a day on which banks are open for general banking business in the

state or territory in Victoria, excluding Saturdays and Sundays and

gazetted public holidays.

Black Swans Those athletes who have been selected to represent Australia in the

Australian First Nations netball team, known as the Black Swans for the

relevant competition or event.

**Conflict of interest** A conflict between personal and professional interests. This includes but

is not limited to the following interests: family member, close personal

relationship, current coach.

**Diamonds** Those athletes who have been selected to represent Australia in the final

Australian team selected for the relevant competition.

**EGM Netball** Means the person holding that position at NA from time to time, including

any person acting in that position or in an equivalent role if the job title is changed, or as delegated by the EGM Netball to an appropriate alternative role holder (such as NA Head of Performance), as referred to in this Policy

and responsible for the nominated area.

First Nations Tournament 23/Under age based national competition between Member Organisation

teams of First Nation Athletes. If the competition ceases to exist or its name is changed in any way and for any reason, any subsequent or successor competition substantially similar to the First Nations

Tournament that is conducted by NA.

Head of Pathways The NA role (or equivalent role if the job title is changed) as referred to in

this Policy.

**Interested Party** See clause 9.4 of this Policy.

overseas.

National Netball

Championships (NNC)

National Selectors Those appropriately qualified persons to determine selection to the

National Program who have been appointed to this role by NA.

**Netball Australia (NA)** The national entity which is a member of and is recognised by WN as the

entity governing Netball in Australia.

Non-selected Athlete Any athlete who is not selected by NA to any National Program.

Pathways The Netball Australia high performance pathway program targeted at

future national team athletes.

**Selected Athlete** Any athlete selected by NA to a National Program.

**Squad Camps** Squad based camps conducted under the auspices of Netball Australia.

**Suncorp Super Netball** 

(SSN)

The highest level domestic competition conducted by Netball Australia featuring eight Australian teams. If the competition changes its name or ceases to exist any subsequent or similar competition substantially similar to the Suncorp Super Netball that is conducted by Netball

Australia

**World Netball (WN)** Formally the International Netball Federation is the international

federation recognised by the International Olympic Committee or the

General Assembly of International Sports Federations as the entity responsible for governing Netball internationally.

#### **Written Notice**

Notice in writing by letter, email or other written means of communication.

All other terms have their ordinary meaning as per the Netball Australia Constitution.

# D. Key Policy Principles

#### A. Eligibility

Athletes are qualified to compete for Australia in the World Netball Championships where they comply with the rules and regulations of WN.

Athletes are qualified to be selected for national squads and compete for Australia in Test Matches where they are eligible to participate in the World Netball Championships for Australia.

First Nations Athletes are qualified to be selected for the Black Swans and compete in relevant competitions and events where they have previously competed in the First Nations Tournament.

#### B. Terms and Conditions

Athletes agree to terms and conditions of the playing contract and/or event participation agreements with NA and WN, as applicable.

Where an athlete does not wish to stand for National Selection, the athlete must complete Annexure 1 in accordance with the Policy and within the time period advised by NA.

#### C. Selection

Selection for National Program teams, squads or events is based on the integrity, objectivity and discretionary application of selection criteria of the relevant selection panel and the provisions of this Policy and its Addendum.

#### D. Athlete Wellbeing

All squad members not selected in a team are to be provided with feedback and have access to confidential counselling services facilitated by NA.

- E. This Policy remains in force unless otherwise determined by the Netball Australia Board.
- F. Any change to this Policy shall be notified to relevant persons in accordance with the provisions of the Constitution and By Laws.

#### E. Other Related Policies and Documents

The following policies and documents also apply to the application of this Policy and must – where relevant - be adhered to at all times:

- a) Netball Australia Constitution;
- b) Diamonds Collective Bargaining Agreement;
- c) National Selector Position Description;
- d) National Underage Selector Position Description;

- e) World Netball Regulations;
- f) Athlete Categorisation Guidelines; and
- g) All other relevant and related documentation including policies and agreements.

#### 1. NA National Selectors

1.1 National Selectors who determine Selection of Athletes for National Program squads and teams will comprise of:

- 1.2 Qualified National Selectors for the National Program squads and teams outlined in clause 1.1 above are appointed via a recruitment and selection process conducted by the Appointments Panel consisting of the NA EGM Netball, the National Coach and the NA Head of Performance.
- 1.3 All National Selectors and/or Delegate/s will have demonstrated elite level coaching experience, hold a minimum advanced coach accreditation and/or have experience as a national/international player. In addition, the First Nations Selector will be of First Nations cultural heritage.
- 1.4 Head Coaches on a current contract to coach a Suncorp Super Netball team are not eligible to be a National Selector.
- 1.5 The Appointments Panel has authority to amend the composition of a Selection Panel at their discretion, including the appointment of additional selectors.
- 1.6 The EGM Netball will seek the endorsement of the NA Chief Executive Officer for all National Selector appointments and this endorsement must be received for the National Selector appointment to be valid.
- 1.7 The National Selector position descriptions set out the roles and responsibilities for which each National Selector appointment is based and may be amended from time to time at the sole discretion of NA.

- 1.8 Where any person appointed under this Policy becomes an employee of NA, NA employees must comply with codes and policies of NA, including but not limited to all NA policies, procedures, Code of Conduct and the Integrity in Netball Framework.
- 1.9 All National Selector positions will be appointed for a period of two years. At the discretion of the EGM Netball, appointment terms may be for shorter periods of time but not greater. All other selection positions are appointed at the discretion of the EGM Netball.
- 1.10 In the event that one or more of the persons appointed to the National Selector roles listed in the table above at clause 1.1 above is unable to perform their role for any reason whatsoever, the Appointments Panel will appoint an appropriately experienced delegate to perform the role left open and will notify all relevant persons and Athletes of the same at an appropriate time.

## 2. NA Athlete Eligibility

- 2.1 Athlete eligibility criteria for selection in Australian Netball Diamonds, Australia Development/Australia A and Australian 21/Under squads:
  - 2.1.1 Meet the eligibility criteria as detailed by World Netball (located <a href="here">here</a>);
  - 2.1.2 Be a registered member of a Member Organisation of Netball Australia and therefore a member of Netball Australia;
  - 2.1.3 Have not breached National Anti-Doping Policy or the World Netball Anti-Doping Rules unless the athlete has already been sanctioned by the breach and completed the sanction imposed; and
  - 2.1.4 Have not by their actions or omissions brought themselves or Netball into disrepute, censure or scandal.
- 2.2 The NA Chief Executive Officer shall have the power to waive clause 2.1.1 at their sole discretion, but only after a recommendation is received in writing to do so by the EGM Netball.

## 3. Selection

- 3.1 Selection may be made by reference to an Athlete's performance throughout the following events:
  - 3.1.1 International Test matches, including Commonwealth Games and WN events.
  - 3.1.2 Australian Diamonds program activities under the direction of the National Coach, including preparation hubs, other training activities, camps and tours.
  - 3.1.3 Suncorp Super Netball.
  - 3.1.4 Other national league competitions conducted by a Full Member of WN that is of equivalent standing to the Suncorp Super Netball League as determined by Netball Australia. As at the date of this Policy, this includes the ANZ Premiership, conducted by Netball New Zealand and the Super League, conducted by England Netball.
  - 3.1.5 National Netball Championships.
  - 3.1.6 First Nations Tournament (for Black Swans Program only).
  - 3.1.7 SN Reserves, and Member Organisation top tier competitions (i.e., Premier League/State League).
  - 3.1.8 Squad Camps.

- 3.2 In addition to those events detailed in clause 3.1 above, NA may notify Athletes of other events to be considered or referenced for selection purposes, at the commencement of each calendar year or such other time as nominated by NA.
- 3.3 Australian Netball Diamonds squad selection may occur up to twice yearly at times to be advised to Athletes by NA.
- 3.4 Notwithstanding clause 3.3 above, any Athlete can be added or removed from the Australian Netball Diamonds squad at any time in accordance with this Policy.
- 3.5 Where an Athlete does not wish to stand for National Selection, they must complete the Opt Out form set out in Annexure 1 of this Policy and within the time period determined by NA. Athletes who have publicly announced their retirement from representing Australia internationally are not required to submit the Opt Out form.

## 4. NA Squad and Team Composition

- 4.1 The Australian Netball Diamonds squad shall comprise up to 22 athletes (with a maximum of 18 Athletes selected in the 'Initial Contracted Diamonds' and up to 4 Athletes selected from the Invitees, in accordance with the Diamonds Collective Player Agreement).
- 4.2 The Australia Development/Australia A squad shall comprise up to 22 athletes.
- 4.3 The Australia 21/Under squad shall comprise up to 22 athletes.
- 4.4 The Black Swans squad shall comprise of up to 20 Athletes.
- 4.5 The number of Pathway squad, team and camp selections will be determined from year to year at the discretion of the EGM Netball.
- 4.6 Invitees may be invited into the squads at the discretion of selectors, and in accordance with any Collective Player Agreement.
- 4.7 The official team, where appropriate, shall comprise 12 selected athletes and up to 3 travelling reserves, from the applicable squad.
- 4.8 Where an athlete is selected in one squad and eligible for another, in the event that the athlete is subsequently selected in the more senior squad, their position in the original squad may be replaced at the discretion of the Selection Panel.

#### 5. Selection Criteria

- 5.1 In exercising their sole and absolute discretion, NA National Selectors may select based on one or more the following selection criteria:
  - 5.1.1 Previous international and national performances.
  - 5.1.2 Current international and national performances.
  - 5.1.3 Current or previous level of skill and physical fitness.
  - 5.1.4 Current or potential injury or condition which may impair, inhibit or prevent the participant's performance to the requisite level.
  - 5.1.5 Composition and balance of team including but not limited to position coverage.
  - 5.1.6 In the case of the Pathway, positions identified as critically important at the national level.

5.1.7 Other factors considered by the selectors to be important.

## 6. NA National Selector Responsibilities

- 6.1 The NA National Selector panel decision is final. Reasons for selection or non-selection are not required to be communicated to Athletes or others as part of the selection process.
- 6.2 Any final selection decision rests with the appointed Chair of the National Selectors panel.
- 6.3 Where an Athlete is unable to fulfil squad commitments the National Selectors panel has the ability to promote eligible Athletes to the applicable squad.
- 6.4 The National Selectors panel has the ability to make changes and substitutions to squads and teams at their discretion.
- 6.5 A National Selector with a conflict of interest must notify the EGM Netball of the conflict as soon as they become aware it exists. Where the EGM Netball has a conflict of interest, this must be notified to the NA Chief Executive Officer as soon as they become aware it exists.
- 6.6 A National Selector that, in the opinion of the Appointments Panel or the EGM Netball or the NA Chief Executive Officer, has an unmanageable conflict of interest will remove themselves from the selection or resign as a National Selector.
- 6.7 A National Selector may advise the EGM Netball of another National Selector's conflict of interest in the event that the risk has been overlooked.
- 6.8 As directed by the EGM Netball, a National Selector will:
  - 6.8.1 Attend all selection activities (i.e. meetings, events, trainings, teleconferences) as deemed necessary by NA.
  - 6.8.2 Act with integrity and objectivity in all aspects of the selection process in complying with this Policy and other related policies and documents.
  - 6.8.3 Maintain detailed records and selection materials to ensure that communications and meetings are appropriately recorded.
  - 6.8.4 Keep all selection activity confidential to the National Selectors panel and appropriate NA staff.
- 6.9 A National Selector who is unable to fully meet all the requirements of this clause 6.8 may resign or be removed and replaced on the panel, subject to this Policy.

# 7. Athlete Removal from Squad/Team and Extenuating Circumstances

- 7.1 An Athlete may be removed from a squad/team at the sole discretion of NA due to a range of matters, including, but not limited to:
  - 7.1.1 Failure to adhere to the National Code of Conduct and Terms of Agreement;
  - 7.1.2 Injury or illness resulting in the athlete's incapacity to fulfil obligations;
  - 7.1.3 Performance, skill and/or fitness levels are not at benchmark standard;
  - 7.1.4 Breach of the NA Constitution, Anti-Doping Policy, National Integrity Framework Policies or other policies or procedures as deemed applicable to the National Program; or

7.1.5 Failure by the Athlete to meet the NA Eligibility Criteria outlined in this Policy.

# 8. Wellbeing

- 8.1 Successful and unsuccessful Athletes may be advised of selection outcomes prior to public announcement. Such advice is subject to strict confidentiality obligations for the purpose of ensuring each Athlete receives wellbeing support.
- 8.2 Standard operating procedures for team selection will be implemented and wellbeing support will be made available to all squad Athletes by NA as required.

## 9. Selection Appeals

- 9.1 A Non-Selected Athlete may appeal against their non-selection to a National Program (**Selection Appeal**) in accordance with the procedures set out in clause 9.10 to 9.14 (inclusive) of this Policy. For clarity, Athletes can only appeal their non-selection for a National Program that has been formally selected in line with clauses 2 and 3 of this Policy.
- 9.2 In the event that two or more Selection Appeals are brought under this Policy and it appears to the NA Tribunal that:
  - 9.2.1 the Selection Appeals involve a common question; or
  - 9.2.2 the relief claimed in them are in respect of, or arise out of, the same instance of selection; or
  - 9.2.3 there is some other reason for it being desirable to have the Selection Appeals consolidated,

the Selection Appeals must, so far as practicable, be consolidated and heard together and the Athletes involved in the Selection Appeals must provide reasonable assistance to the NA Tribunal to achieve this outcome.

#### Parties to a Selection Appeal

- 9.3 The Parties to a Selection Appeal will be:
  - 9.3.1 the Appellant;
  - 9.3.2 NA; and
  - 9.3.3 any Interested Party.
- 9.4 An Interested Party to a Selection Appeal must be either:
  - 9.4.1 a Selected Athlete for the National Program which is the subject of the Selection Appeal; or
  - 9.4.2 a Non-Selected Athlete otherwise eligible for selection to the National Program which is the subject of the Selection Appeal.
- 9.5 NA and the Appellant must identify and propose to the NA Tribunal, Athletes who may be Interested Parties. Athletes may also identify themselves to the NA Tribunal as potential Interested Parties.
- 9.6 In the event that any doubt should arise as to the eligibility of a person as an Interested Party, NA shall determine the matter in its absolute discretion.

- 9.7 An Athlete identified as a potential Interested Party must, in order to participate in the Selection Appeal, indicate to the NA Tribunal that they wish to be a party to the Selection Appeal.
- 9.8 An Interested Party:
  - 9.8.1 must receive notice of the Selection Appeal from NA;
  - 9.8.2 must be given the opportunity to make submissions in the Selection Appeal and give evidence:
  - 9.8.3 must receive a copy of the determination handed down by the NA Tribunal; and
  - 9.8.4 will be bound by any such determination.
- 9.9 A person who receives notice from NA of their identification as an Interested Party may decline to participate as an Interested Party at any time, in which case that person will automatically waive any rights afforded to an Interested Party.

#### Appeal process

- 9.10 Steps prior to Selection Appeal
  - 9.10.1 A Non-Selected Athlete must not commence a Selection Appeal unless the provisions of this clause 9.10 have been complied with.
  - 9.10.2 Within 24 hours of the time that a Non-Selected Athlete receives notice of their non-selection, the Non-Selected Athlete must provide Written Notice to the CEO of NA that the Non-Selected Athlete disputes their non-selection.
  - 9.10.3 The Non-Selected Athlete must provide reasons to support their notice of dispute.
  - 9.10.4 Within 24 hours of the Non-Selected Athlete providing Written Notice to the CEO of NA in accordance with clause 9.10.3, the CEO of NA must provide the Non-Selected Athlete with a written statement of NA's reasons supporting the non-selection of the Non-Selected Athlete.
  - 9.10.5 Within 24 hours of a Non-Selected Athlete receiving NA's written statement in accordance with clause 9.10.4, the Non-Selected Athlete must provide a written response to the CEO of NA which indicates whether the Non-Selected Athlete intends to proceed to a hearing of their Selection Appeal in accordance with clause 9.11.
  - 9.10.6 The Parties must use their best endeavours, acting in good faith, to resolve the dispute through communication in accordance with this clause 9.10, made on a without prejudice basis and kept confidential between the Parties.
  - 9.10.7 For the avoidance of doubt, any formal written notice (and reasons) or statement made by the CEO or the Non-Selected Athlete in accordance with clauses 9.10.2 to 9.10.5 may be submitted to the NA Tribunal for the purposes of the Selection Appeal.
  - 9.10.8 For clarity, time periods referred to in clause 9.10 may be extended by agreement of NA and the Non-Selected Athlete in advance.

#### 9.11 NA Tribunal

9.11.1 A Selection Appeal will be heard by the NA Tribunal consisting of three panel Tribunal Members, with a Chairperson, appointed by the NA General Manager Legal & Integrity (in

- their absolute discretion) from the Tribunal Panel. The Tribunal Members must have had no prior involvement with the matter.
- 9.11.2 A Non-Selected Athlete may bring a Selection Appeal to the NA Tribunal for hearing on one or more of the following grounds, which the Non-Selected Athlete (Appellant) bears the onus of making out:
  - (a) that this Policy was not properly applied by NA with respect to the Non-Selected Athlete;
  - (b) the Non-Selected Athlete was not afforded a reasonable opportunity by NA to satisfy this Policy;
  - (c) NA was affected by actual bias in making its decision to not select the Non-Selected Athlete; and/or
  - (d) there was no material on which NA's decision could be reasonably based.
- 9.12 Making an Application for a Selection Appeal
  - 9.12.1 A Non-Selected Athlete wishing to make an application for a Selection Appeal to the NA Tribunal must, within 24 hours of indicating to the CEO of NA their intention to proceed to a hearing of their Selection Appeal under clause 9.11, complete and lodge the Notice of Appeal (see Annexure 2).
  - 9.12.2 For clarity, unless agreed by NA and the Non-Selected Athlete, an extension of time to make an application for a Selection Appeal may be granted by the NA Tribunal under this clause only in extenuating circumstances outside the control of the Non-Selected Athlete concerned.
- 9.13 Selection Appeal Procedure
  - 9.13.1 A Selection Appeal heard by the NA Tribunal will proceed in accordance with the specific procedural matters set out below, and any procedures the Chairperson sees fit having regard to all the circumstances and the principles of natural justice:
    - (a) Where the NA Tribunal considers it appropriate to do so and all the involved Parties to the Selection Appeal agree, the NA Tribunal may determine the Selection Appeal without a hearing.
    - (b) The NA Tribunal must provide Written Notice to the Parties of its determination as soon as reasonably practicable after the conclusion of the hearing (in most cases, within 24 hours of the conclusion of the hearing). The NA Tribunal will provide the Parties with a statement of the reasons for its determination within 3 Business Days of notifying the Parties of its determination.
    - (c) The determination of the NA Tribunal is final and binding on the Parties.
- 9.14 <u>Selection Appeal Outcomes Reconsideration and Redetermination</u>
  - 9.14.1 The NA Tribunal may uphold or dismiss a Selection Appeal.
  - 9.14.2 Subject to clause 9.14.4, where the NA Tribunal upholds a Selection Appeal overturning the original selection decision, the NA Tribunal must refer any subsequent decision regarding the Appellant's non-selection or if required, any broader decision regarding selection of the National Program back to NA for reconsideration and redetermination.

- 9.14.3 In reconsidering and determining the Appellant's non-selection or if required, any broader decision regarding selection of National Program, NA must observe the principles of natural justice. Any decision made by NA regarding the Appellant's nomination after such referral, is final and binding on the Appellant.
- 9.14.4 Notwithstanding clause 9.14.2, the NA Tribunal may itself determine the issue of the Appellant's selection, or broader decision regarding selection of the National Program where the NA Tribunal determines that:
  - (a) it would be impractical to refer the selection decision for redetermination to NA given the time available; or
  - (b) in making its original decision, NA had such disregard for proper application of this Policy that a reasonable person would apprehend that it is unlikely that this Policy would be applied properly by NA if the decision regarding the Appellant's nonselection was referred back to NA.
- 9.14.5 Prior to making a determination under clause 9.14.4 the NA Tribunal must advise the Parties that the NA Tribunal intends to make such a determination and provide the Parties with a reasonable opportunity to make submissions in relation to the NA Tribunal's proposed determination. The NA Tribunal must give proper consideration to any submissions it receives pursuant to this clause 9.14.5.

# 10. Policy Review

This Policy is subject to ongoing monitoring and review by NA at its sole discretion and depending on the needs of the business.
