## 1. AUSTRALIAN NETBALL PERSONAL INFORMATION COLLECTION NOTICE

This Personal Information Collection Notice is intended to notify you about our collection of your Personal Information (as defined in the Privacy Act 1988). We collect, store, use, disclose and otherwise handle your personal information for our legitimate functions and activities in accordance with our Privacy Policy which you can read here: <https://netball.com.au/privacy-policy>

When used in this Personal Information Collection Notice, depending on the context, “we”, “our” and “us” refer to the relevant Australian Netball Organisation (ANO) that is collecting your Personal Information. The ANO’s and their contact details are listed further below.

The Personal Information we collect about you; when, why and from whom we collect it (you or a third party); the consequence of failing to supply it; and, with whom and where we might disclose it, will vary from individual to individual depending on the purpose of collection.

## 2. WHAT WE COLLECT

Depending on the circumstances, the personal information we may collect about you is set out in our Privacy Policy and includes (without limitation):

- your contact information, such as your name, phone numbers, mobile numbers, occupation, address details, emergency contact details, emails addresses and social media details;
- your date of birth, age, gender and image and audio & visual recordings of you;
- your school, if applicable;
- your parent / guardian / referee, if applicable;
- details of your netball participation registrations;
- details of your netball competition registration information, such as clubs and teams played with;
- your playing data, statistics, results and ranking;
- other information you elect to provide, such as disability, languages spoken at home, if you identify as Indigenous or Torres Strait Islander, country where your parents were born, favourite Super Netball Club;
- financial or payment information; and
- identification numbers such as your driver’s licence, passport, ambulance membership.

Depending on the circumstances, the personal information we may collect about you might be provided by a third-party including (without limitation):

- another ANO;
- State and Territory Member Organisations, Regional Associations or Affiliated Clubs;
- the International Netball Federation, other national netball organisations or tournament organising committees;

- another sporting organisation, agency or body (such as the Australian Olympic Committee, Sport Integrity Australia, the Australian Sports Commission, Paralympics Australia or Commonwealth Games Australia) and their international counterparts;
- the Australian Institute of Sport and State/Territory Institutes/Academies of Sport;
- your parent / guardian, next of kin or emergency contact;
- recruiters or your nominated referee in the case of recruitment activities;
- a prospective, current or past supplier, sponsor or business partner that tells us you as their referee or colleague;
- your network;
- your coach, club, team or teammates;
- NA's authorised betting providers;
- statisticians or sports data providers (including via technological means);
- law enforcement bodies; and
- social media channels.

### 3. CONSEQUENCES FOR FAILING TO PROVIDE PERSONAL INFORMATION

Depending on the purpose of the collection if you fail to provide us with all or part of the personal information we require, then we may not be able to:

- process or manage your registration, subscription, request, feedback, query or complaint (howsoever described);
- open, maintain or renew an account for or with you or the organisation/s you represent;
- communicate or engage with you properly or deliver our products and services to you;
- register, attend, participate in netball programs, events or activities conducted by us or our partners or suppliers; and
- hire, engage, do business with, transact with or pay / be paid by you or the organisation/s you represent.

### 4. PURPOSES OF COLLECTION

Depending on the circumstances, we collect personal information from or about you for a variety of purposes, most of which are set out in our Privacy Policy which include (without limitation):

- providing activities, products, goods and services that you request from us;
- engaging with you and sending communications about our programs and competition participation;
- personalising and improving user experience on our digital platforms;

- carrying out consumer profiling and market research;
- to assist other Australian Netball Organisations, State & Territory Member Organisations, Regional Organisations or Affiliated Clubs;
- to administer, manage and improve our online systems;
- to assist law or sports integrity or anti-doping enforcement bodies, as required by law or when considered necessary or appropriate; and
- raising your awareness of opportunities and special offers, such as introducing you to Suncorp Super Netball (or such other name given to that, or a similar or replacement competition, by NA), Australian Diamonds, tournament tickets, sponsor offers and other promotions.

## 5. DISCLOSURE

Depending on the purpose of collection, we may disclose your personal information to third parties for the same primary or secondary purposes as we collected it, most of whom are set out in our Privacy Policy which include (without limitation) other ANO's, the State and Territory Member Organisations, Regional Associations, Affiliated Clubs, our suppliers, ticketing providers, marketing providers, fulfilment providers, IT and data providers, professional service providers & advisers, medical practitioners, law enforcement or sporting integrity agencies, the International Netball Federation, Australian Olympic Committee, Paralympics Australia, Commonwealth Games Australia (and international equivalents), the Australian Sports Commission (Sport Australia) or State/Territory equivalents, the Australian Institute of Sport, State/Territory Institutes/Academies of Sports, Sport Integrity Australia, the World Anti-Doping Agency, the National Sports Tribunal, and other relevant bodies. For instance, if we collected personal information so as to fulfil a merchandise order then we may disclose your personal information to a delivery company; or, if we collected personal information so as to add you to our mailing list then we may disclose your personal information to an email marketing provider.

## 6. OVERSEAS DISCLOSURE

Depending on the purpose of collection, we may disclose your personal information to third parties located overseas, including (without limitation) in the USA, the United Kingdom, the European Economic Area, Switzerland, New Zealand, Singapore and Japan. This might include (without limitation) for: data hosting, storage or processing purposes; obtaining advice; IT development, support, maintenance or training; data archive, back-up or redundancy; assisting us communicate, engage, transact or do business with you; delivering goods or services to you; arranging travel, accommodation and related activities for you. Please contact our Privacy Officer if you require further details.
